More than 16 percent of gross domestic product (GDP) is spent on providing health services in the United States. Over the past three years, the nation has faced an unprecedented economic downturn, leaving states with a tremendous loss of revenue. As state legislatures scrutinized state spending and were forced to balance budgets through a combination of reducing expenditures and increasing revenues, health services were not spared from cuts. As states look to yet another challenging fiscal year, they face constituency calls to ensure services for the most vulnerable. It is vital that legislators address the critical issue of healthcare cost in the context of the current economic situation, as states spend on average between 28 to 35 percent of their annual budgets on health-related costs. This session will provide an overview of the budgetary outlook for states, and highlight state health financing strategies to make fiscal improvements, while providing health access and coverage for their most vulnerable populations.

The Affordable Care Act was signed into law by President Barack Obama on March 23, 2010, marking an historic undertaking by the federal government to increase access to medical coverage for the U.S. population. Since its passage, key provisions have gone into effect. At the same time, in January 2011, the U.S. House of Representatives voted to repeal the law in a largely symbolic gesture. The Act has been challenged in court on the grounds that its requirement -- that individuals either have insurance or pay a fine -- is unconstitutional. This presentation will provide an overview on the status of the Act and the developments to which Latino policymakers should pay close attention as it is rolled out and implemented across the country.

The federal government recently reported that insolvency looms for its entitlement programs, including Medicare, which now provides health insurance to some 47 million elderly and disabled Americans. At the same time, many argue that entitlement programs run by the states are not sustainable at their current rate of growth. This session will provide a current overview of entitlement programs at the state level and explore strategies for preserving these important safety nets for vulnerable populations in a fiscally responsible way.

**Hearing III – Laying the Foundation: Structuring Insurance Exchanges**

By January 2013, states must inform the federal government if they will be prepared to operate an insurance exchange one year later in 2014 when this provision is to be implemented. The health insurance exchange is a centerpiece of the private insurance reforms in the Affordable Care Act. If the exchanges work as planned, they will expand coverage to more Americans, reduce insurance costs, and improve the quality of coverage and perhaps of health care itself; yet, previous attempts at creating health insurance exchanges have had mixed results. In implementing the exchanges, Latino policymakers have the opportunity to play a leadership role in trying to avoid the problems that have undermined previous exchanges. This session will provide an overview of how insurance exchanges work, and how to best structure an exchange in your state.
